#### **Greetings from the Board**

Late spring and the leaves are back! The change back to green trees is always welcome in our home.

I want to take this opportunity to explain some things that the board is discussing. We have been looking at a change to Covenant 9.18. This rule currently allows the board to add rules that they see are needed. This has been done many times in the past and is not improper in any way. However, the current board fells that there may be a need to have the community look at that rule. Any board past present or future can use 9.18 to impose additional rules on what a homeowner can do with their property.

We feel that when a board adds a new rule, as soon as practical the community should have the opportunity to vote on whether or not they support that rule. It is very important to keep in mind that no board has the ability to change a covenant. Any change must have 500 positive votes from the community to effect a change. What we are in fact trying to do, if the community votes for it, is to limit the power of the board to impose new rules on how you can use your property. This keeps the power in the hands of the community not the board. So, we have a motion which is currently being reviewed by our attorney. Should the attorney give the go ahead, the board will vote to have the matter added to the next election for the community to decide if that's what they want.

Taking power away from the board and letting the community decide what restrictions they want in our opinion is a good thing. We will see what the community says at election time.

Again, the board cannot change any covenant without a vote from the community.

This is a matter that has been being discussed for some time because it is, in our opinion, very important.

I would also like to take the opportunity to welcome Mrs. Marsha Johnson as the chairperson of the ECC. We have been working very closely to move forward as a group and continue to do what is best for our community.

There was no April meeting. Important dates and deadlines follow in this article.

The 2024 Election Calendar and Members have been posted on the CCPOA website. The calendar includes the bylaws 4.1 & 4.2 DEADLINE: Tuesday, August 20, 2024. It is the *responsibility of the property owner* to inform the CCPOA office of current information (email, address, phone number) for the CCPOA database. The Election Committee uses the CCPOA database for CCPOA Elections.

- Property owners must be in *good standing* with all dues and assessments paid-in-full by Tuesday, August 20, 2024 in order to receive a ballot in our September 2024 election;
- Property owners must update the CCPOA office with *current emails*, *phone number*, *and addresses for the database* by Tuesday, August 20, 2024 in order to receive a ballot in the September 2024 election;
- Property owners must keep the office updated on *all buying and selling of properties* by Tuesday, August 20, 2024 in order to receive a ballot in the September 2024 election for purchased properties.

The formal Election Committee Start-up meeting is Tuesday, May 7, 2024. The Election Committee calendar will drive the 2024 Election. The 2024 Election Committee Calendar is posted on the CCPOA Website and at the end of this newsletter. All subsequent meetings will be workshop format implementing decisions made at the formal meeting. The Election Committee's Start-up meeting will be videotaped and posted on the CCPOA website.

Watch for Constant Contact Election Committee E-Mail BLASTS throughout the summer. You must have a current email addresses in the CCPOA database to receive these. There will be four (4) BOD positions open for the September 2024 election. Please keep current with our BOD on possible covenant amendments.

#### Security Report for March, 2024


Tennessee traffic law title 55–8–143 Signals for turns:

- (a) Every driver who intends to start, stop or turn, or partly turn from a direct line, shall first see that that movement can be made in safety, and whenever the operation of any other vehicle may be affected by such movement, shall give a signal required in this section, plainly visible to the driver of the other vehicle of the intention to make such a movement.
- (b) The signal required in this section shall be given by means of the hand and arm, or by some mechanical or electrical device approved by the department of safety, in the manner specified in this section. Whenever the signal is given by means of a hand an arm, the driver shall indicate the intention to start, stop, or turn, or partly turn, by extending the hand and arm from and beyond the left side of the vehicle, in the following manner:
- (1) for the left turn, or to pull to the left, the arm shall be extended in a horizontal position straight from and level with the shoulder;

- (2) for the right turn, or pull to the right, the arm shall be extended upward; and
- (3) for slowing down or to stop, the arm shall be extended downward.
- (c) These signals shall be given continuously for a distance of at least 50 feet (50') before stopping, turning, partly turning, or materially altering the course of the vehicle.



#### **Safety & Security**

The Putnam County Sheriff's Office does vacation home checks for Putnam residents. You need to go to their website: <a href="http://p2c.countywide.us/p2c-pcso/">http://p2c.countywide.us/p2c-pcso/</a> and click on the heading "Security Watch". It gives you a form to fill out and file with the SO. The watch is not automatic, but has to be reviewed and approved by them. If approved they will notify you by email. In Cumberland County you call their main number (931) 484-6176 and ask for dispatch. You give them your information and they enter it into their Extra Patrol Log.

#### **Notice for Home and Property Owners**

As a reminder, it is very important if you are selling, buying or moving that you contact the Cumberland Cove Welcome Center – 931-839-2926 to provide ownership or address changes. Without your current address information, all correspondence such as annual statements will be sent to the address we have on file. This may cause a delay in receiving your statement for your annual dues. We also keep our Cove phone book updated with this information. We do not know when you move or new ownership takes place, unless you notify us. PLEASE do not rely on Realtors, Attorneys, or Title Offices the pass this information on.

We have Welcome Packets for new property/home owners, with useful information in them. So if you are new to Cumberland Cove, please stop by the Welcome Center Monday – Friday between 9:00 and 1:00 to receive your welcome packet.

#### **Use of Cove Assets and Equipment**

Cove Assets and equipment are for official Cove use only. Chain saws, weed eaters, the tractor, the truck, and any equipment used by committees are for their official use only. Individuals may NOT borrow the equipment for personal use.

Equipment at the POA office including chairs and tables can only be used on premises...they cannot be loaned for off-site use, per the current WC Usage Agreement.

#### **Burning in the Cove**

From October 15 to May 15 it is required by law that citizens obtain a burning permit.

For a leaf or brush pile less than 8 feet by 8 feet, log

onto <u>www.BurnSafeTN.org</u> for approval and to receive a burn permit. For a larger burn, call your local Division of Forestry burn permit number: For Putnam County it is 931-839-2328; for Cumberland County it is 931-484-4548.

The person burning is legally responsible for any fires that burn another person's property, so it's better to be safe then sorry.

We encourage anyone that is going to burn outdoors to borrow one of our *water* backpack extinguishers. They are very easy to use and they are very effective on small fires before they become large, *out of control* fires.

The cove *Firewise* committee has several of these *water backpack* extinguishers and *fire rakes* at the maintenance shed for loan out to cove residents.

It is against our covenants and against state law to leave any fire unattended! For suspected violations, please call 9-1-1.
